We are seeking an exceptional individual to join our team as an Operations Captain. The ideal candidate in this role should have a positive attitude, an active, energetic mind, and a leadership style that is characterized by highly ethical practices and a commitment to diversity, openness, flexibility, integrity, and kindness.

Under general supervision of the Chief of Police, the Operations Captain is responsible for providing leadership in management to personnel, direct and indirect supervision of all personnel assigned to Patrol Operations, Communications Unit and the Irvine Center to include policy formulation and execution. Responsible for the protection of life and property and the enforcement of all pertinent laws within the jurisdiction of the University Police Department, California State University, Fullerton. Coordinates identify and correct operational deficiencies within areas of responsibility in an appropriate and timely manner. Responsible for special event planning, personnel performance evaluations, overseeing the patrol deployment schedule and other staffing needs, police fleet management, and serves as the University's Whistleblower contact. Manages the day-to-day operations of the Communications Unit. Responsible for maintaining, recommending for purchase and documentation of police vehicles and related equipment.

The Operations Captain is responsible for the training, deployment, legal compliance, policy formulation and execution of all Special and General Orders, including but not limited to, storage data for the Body Worn Cameras (BWC), the Naloxone program, deployment of 2- Explosives Detection Teams (Officer Handler and Bomb Sniffing K9), and 2 motorcycle traffic enforcement officers. Other duties as assigned.

### **Essential Qualifications**

POST Management Certificate. A Bachelor's Degree with at least 10 years of law enforcement experience of which at least two years at the rank above Sergeant. Law enforcement experience with a California POST agency or ability to get a POST waiver if experience is outside of California.
